

Privacy Policy

The purpose of this Privacy Policy is to demonstrate to all visitors of this site that TCoU (Take Care of You) Company is committed to protecting all privacy rights for parties visiting our website, buying our products, or participating in any of our online events.

TCoU respects everyone's privacy and TCoU is committed to protecting companies' or individuals' identifiable information. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Site and how such information may be used and/or shared with others.

This Privacy Policy is specific and applies only to information collected through the TCoU website and not through any other sources. This Privacy Policy is subject to TCoU's "Terms and Conditions" (see "Terms of Use, Terms of Sale and Conditions"). Security of Personal or Company Information Provided to TCoU There are two types of information that we gather from visitors of our website:

Information willingly submitted by the individual to TCoU

This Privacy Policy governs your experience on this TCoU website, and any associated TCoU webpages, including TCoU pages or apps through a mobile device unless otherwise indicated.

Automatically Collected Information

Automatically collected information is gathered to provide TCoU a way to measure the website's traffic and the success of visitor's navigation of our website to make TCoU site more useful to its visitors. This information is collected on a temporary basis and purged as needed to make the proper website traffic analysis. This information is only used and viewed by TCoU's Web Coordinators. TCoU or third-party website partners may use cookies to collect this information. The automatically collected information is only limited to system/devices and frequency items such as:

- Visitor's Internet domain server address, IP address, browser type or protocol and website address.
- The Country the visitor is registered.
- Date and time TCoU website was visited.
- Type of Web Browser and Operating System used.
- Length of time a visitor navigated through the TCoU site.
- Favorite pages viewed on the TCoU site and frequency.

Information willingly submitted by Customers/Followers to TCoU via website or other electronic means

TCoU collects information from individuals when they willingly submit it for purchases, requesting newsletters, participating on different events, blogs or via social media sites and links.

The information collected may includes, but is not limited to, individual's full name, a user name and password when setting up a blog id, email address, phone number, physical address, credit card information and other billing information at time of purchases.

Additional information collected may also include individual's friends contact information to invite and share experiences via TCoU's website or social media sites. TCoU will use e-mail address provided by individuals for status update of purchases and to follow up on service level.

When individuals sign up for newsletters, TCoU may send out newsletters or marketing e-mail messages to e-mail addresses provided by individuals regarding new collections, upcoming sales or promotions, new blog stories, new contests, campaigns, challenges updates or other hot new topics. To cancel such communications, please email us at help@tcou.online and put "**Unsubscribe**" in the subject line.

When individuals share stories, pictures, videos or general comments, following a review process, information provided may be uploaded to TCoU site or TCoU social media sites with individual's name and date of submission to share with other TCoU followers.

NOTE: when items are uploaded on social media sites, individuals' names linked to such sites will act as a hyperlink and other users will be able see and could have access to individuals' social media's profile. ALSO: TCoU may collect additional information from other sources, such as social networks and public databases to evaluate algorithms pertaining to areas such as: demographics, interests, and shopping behavior to improve our products and service to TCoU followers.

Customer/Follower Information Privacy Disclosure

TCoU does not share, sell, lease, or rent personal information about our followers and customers to unaffiliated third parties for solicitation purposes. TCoU will share information with Amazon or PayPal for order processing and management of purchases.

Contests or TCoU event participants will have to read the rules for such events/contest and sign a waiver to allow TCoU to use their information and publicly disclose their name, city, and state if they are winners or chosen for event highlights.

TCoU has taken security measure to protect and secure any personal or company information provided by visitors to TCoU via its website for inquiries or participation of any type on the TCoU site. These measures include a firewall and on-going maintenance of information received at the TCoU server.

WARNING: Although TCoU has taken the necessary measures to use reasonable care in protecting and securing all data submitted by visitors, TCoU cannot guarantee full security of such information that was transmitted over the Internet and TCoU accepts no liability for any unintentional disclosure. TCoU only shares necessary information provided by visitors for purchases or services with third parties involved in such transactions (such as Amazon or PayPal). TCoU will not share any customers or site-visitors' information unless disclosure is necessary to: (a) comply with a court order or other legal process; (b) protect our rights or property; or (c) enforce our Terms of Service. We do not collect personal information from visitors to our site unless it is provided to us voluntarily and knowingly.

TCoU reserves the right to disclose and store information as needed in order to comply with legal requests and processes, as stated on TCoU Terms and Conditions of Sale.

As stated on TCoU Terms & Conditions, TCoU will have full rights and ownership of all shared messages, comments, pictures, videos, etc., shared with TCoU via website or social media TCoU sites.

TCoU aims to protect Children's Privacy and recommends that anyone under the age of 18 have an adult help set up the information at time of order, etc.

LINKS TO THIRD PARTY WEBSITES

TCoU may have links to or use third party's Websites, Social Media Pages or Applications for certain processes or services. These third parties will have their own website privacy practices. Shopping at TCoU and Electronic Payments

Any e-commerce transactions/purchases between TCoU and online customers are done via Amazon or PayPal® Official Sites. It is the responsibility of the online visitor to read the privacy policy of Amazon and/or PayPal's site. Amazon and PayPal's system guarantees that all credit card information is encrypted to ensure that no one else can view or capture any private information.

Cookies

TCoU may also send website visitors "cookies" which are small text files from a website that are stored on visitors' hard drive. These small text files make using a website more convenient by saving individuals' passwords and individuals website preferences. Cookies themselves do not contain any personal information. Online visitors have the option to accept or not accept a cookie by resetting their browser to notify them whenever a cookie is being sent to their hard drive. Online visitors may also delete cookies manually from their hard drive.

NOTE: If cookies are deleted some parts of TCoU's website may not function properly or may be considerably slower.
